## Tanner-Foster Scholarship Application Information

The Tanner-Foster Educational Foundation is pleased to sponsor the Tanner-Foster Scholarship Program to AIT students. A current KACE member must sponsor eligible applicants. \$750 reimbursement will be provided to the AIT after successful completion of the NAB and Kansas licensure.

Applications for scholarships must be received by the KACE office via email by July 1, 2023. Please email applications to [resource@kaceks.org](mailto:resource@kaceks.org). Only one scholarship per AIT may be awarded each calendar year. The Tanner-Foster Educational Foundation Board of Directors will review the scholarship applications and determine the recipient. Scholarship recipients will be notified prior to the annual convention in August. The AIT must submit an application prior to taking the NAB exam. Applicants must complete the NAB exam within twelve months from the scholarship award for the funds to be distributed.

The applications will be judged on the following factors:

- ◆ **Requirements** - The application must include a letter of recommendation from the Preceptor, who is a KACE member; an Application for Tanner-Foster Scholarship Form; and a narrative from the AIT. Recommendations from the applicant's family members and/or relatives will not be accepted.
- ◆ **Scholarship Application Form and Narrative** - Applicants must submit a completed application to include a narrative testifying as to the need for financial assistance and desire to pursue or further her/his career as a Kansas Adult Care Home Administrator.
- ◆ **Incomplete Applications** – The scholarship selection committee will consider only applications that are submitted timely with attachments. Incomplete applications will not be reviewed and will be returned to the applicant.

- ◆ **Application Form** - The application form must be completed by the applicant, endorsed by the sponsoring member, and submitted to the KACE office by the deadline.
